### 4. Treasurers Report

#### [2025-26 WCVL Budget](#)

- As mentioned at the last AGM, we had to increase the registration fees due to the need of gym attendants, mvoa fees, and gym fees. Team Fees this season have increased by \$100 per team, for a total registration fee of \$1,660 per team

- Registration fees include the \$100 performance bond. This will be returned at the end of the season, plus/minus team credits or penalties

- team credits and penalties remain the same (i.e. \$10 penalty for not wearing team jerseys, \$50 default game penalty, etc.)

## **5. New Business**

-As previously mentioned, we are looking for gym attendants this season to supervise some of our gyms. Duties include: equipment guidance or check for the setup/takedown, maintaining cleanliness, conflict management. An Honourarium will be given, looking for 2 shifts to be filled at each gym every Sunday at Bernie Wolfe and CPET. Must be 18 years old and willing to address/instruct people if required. Does not have to be a player in the league, but must have access to a cell phone while working.
